NOTE:-

- i) The respective affiliating University will also ensure that all the conditions of N.O.C. of Punjab Government and the conditions of the affiliation are full-filled before allowing admissions in the course.
- ii) The Institute will abide by all the directions of the Government and the University authorized for the counseling relating to admissions in the B.Ed. course.
- iii) Management of the above colleges will submit an Notarized Undertaking to the Coordinator of the Counseling to the fact that they will abide by all the conditions of the N.O.C of the Punjab Government. All such undertakings will be deposited with the D.P.I.(C), by the Coordinator.
- iv) The management of the College at Sr.No.52 will ensure the approval of Town Planning Department regarding land use as Educational and approval of building plan well before 20th Sept.,2006, otherwise it will face dis-affiliation of the College for the session 2006-07 without any prior notice.
